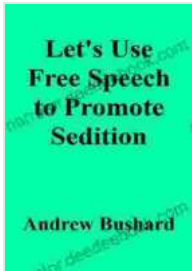

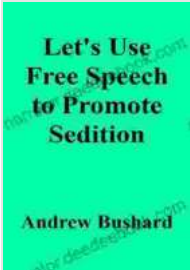
Free speech is a fundamental right, but it is not absolute. We must carefully consider the limits of our right to free expression in order to protect our democracy.
